

CompInfoCenter User Agreement Terms and Conditions

Alabama Self-Insured Worker's Compensation Fund ("ASIWCF") is pleased to provide its CompInfoCenter service (the "Service"). The following terms and conditions apply to your use of the Service. For new users, your electronic acceptance of these terms and conditions indicates your binding agreement to comply with the terms and conditions set forth herein, as the same may be modified from time to time, and you represent that you are duly authorized to accept these terms and conditions on behalf of the entity represented by the data you are accessing. If you are an existing user who has a signed copy of a User Agreement on file with ASIWCF, these terms and conditions supersede that agreement and your continued use of the Service indicates your binding agreement to comply with the terms and conditions set forth herein, as the same may be modified from time to time.

Access to the Service

ASIWCF has provided you an initial User ID. Upon electronic acceptance of these terms and conditions, you will be responsible for activating the User ID, changing the initial Password and providing the assigned User IDs and Passwords to each of your authorized user(s) to access the Service, including the claims data. You represent on a continuing basis that you are authorized to have access to the accounts, the bank account information associated with electronic funds transfers, and the claims data accessed with the User ID(s) and Password(s) provided to you and authorized user(s). You agree to secure the User ID(s) and Password(s) and not to allow any person other than the authorized user(s) to use the User ID(s) and Password(s) to access the Service. You agree that ASIWCF shall not be responsible for any damages or loss resulting from your failure to maintain the confidentiality of your User ID(s) or Password(s). Further, you agree to defend, indemnify and hold harmless ASIWCF, its officers, directors, employees and agents harmless against any liability, losses, damages, or costs and expenses (including attorney fees) arising out of, or resulting from, a third party's access or use of the Service arising out of your provision of or failure to secure the User ID(s) or Password(s) provided to you and your authorized user(s). You expressly agree that your use of the Service is at your own risk. Neither ASIWCF nor any of its officers, directors, employees, agents, contractors, affiliates, information providers, licensors or other suppliers providing data, information or services, warrants that the Service will be uninterrupted or error-free; nor does ASIWCF make any representation or warranty as to the results that may be obtained from the use of the Service. All claims data is for your information and convenience, and may not be and shall not be deemed the official record of account activity. ASIWCF will not be responsible for transmission errors, corruption of data or security of data during transmission via public telecommunications facilities, including the internet.

ASIWCF reserves the right to block access to the Service for any reason, including without limitation: (i) backing up the Service; (ii) maintenance of the Service; (iii) updating the

Service; (iv) maintaining or restoring security to the Service if ASIWCF believes your User ID(s) and Password(s) have been or may be obtained or are being or may be used by an unauthorized person(s); or (v) maintaining the general security and/or integrity of the Service, its data and/or services.

Electronic Funds Transfers

You have the option of making payments to ASIWCF and receiving refunds from ASIWCF through electronic funds transfer (“EFT”).

One Time Payments

If you decide that you would like to make a one-time payment through the Service to pay amounts owed to ASIWCF via EFT, you must provide authorization for ASIWCF to initiate an entry through the Automated Clearing House (“ACH”) networks to debit your bank account for such amount. If you do not agree to provide authorization, you will be responsible for taking appropriate action to pay any amounts owed to ASIWCF.

Automatic Payments

If you decide that you would like to pay ASIWCF on a recurring basis through EFTs by authorizing automatic payments (“Auto Pay”), you must provide authorization for ASIWCF to initiate entries through the ACH networks on a recurring basis to debit your bank account for your then-current balance. If you do not agree to provide authorization, recurring EFT transactions will not be scheduled and you will be responsible for taking appropriate action to pay any amounts owed to ASIWCF.

Automatic Refunds

If you decide that you would like to receive refunds from ASIWCF through EFTs by authorizing automatic refunds (“Auto Refund”), you must provide authorization for ASIWCF to initiate entries through the ACH networks to credit your bank account for the amounts then-owed to you. If you do not agree to provide authorization, EFT transactions will not be scheduled and you will receive refunds from ASIWCF through other methods. A refundable credit may be carried on your ASIWCF member account due to overpayment or transfer from a prior coverage year (including audit credits), whether or not you have authorized Auto Refund. Electing Auto Refund does not remove your responsibility of notifying ASIWCF if you wish to receive a refund that you believe is due to you. See ASIWCF’s Payment Policies and Information document for further detail.

Your authorizations will remain in full force and effect until revoked by you (and we have had a reasonable opportunity to act on your request) or your financial institution. If you un-enroll from Auto Pay, you will still be responsible for payment in full.

If your financial institution refuses an EFT transaction for insufficient funds, closed or unauthorized accounts, or any other reason, your account may be subject to an insufficient funds fee, in addition to any charges your financial institution may assess. If initially rejected, ASIWCF will not make any additional attempts to execute the EFT transaction following the initial

refusal and you will be responsible for taking appropriate action to pay any amounts owed to ASIWCF.

By participating in any EFT service, you are representing that you are the authorized user of the bank account(s) used to make payments to and receive payments from ASIWCF. ASIWCF reserves the right to terminate your future participation in any EFT service for any reason, including but not limited to late payment, non-payment, or fraudulent payment on your account.

ASIWCF undertakes commercially reasonable efforts to provide you complete and accurate quotes, binders, insurance policies, Certificates of Insurance, billing-related information and schedules of loss and claims information through the Service based on the information provided to ASIWCF. Restrictions

If you or your authorized user(s) are authorized under your User ID(s) and Password(s) to input data into the Service or any portion thereof, you represent and warrant that you have the authority and permission to input such data; the data comply with applicable law and do not violate the rights of any person or entity; and the data may be relied upon by ASIWCF. You will be responsible for the accuracy of information you input into the Service. Upon ASIWCF's request, you agree to provide any additional information ASIWCF requests.
